### ANNUAL MEMBERSHIP FOR HCARC IS \$30.

For this low price, you are entitled to use the Benton Grounds for training and you will receive a regularly published newsletter. In turn, you are required to work **TWO** days at events or clean up days held on the grounds. Scheduled events include the Spring Field Trial May 12-14<sup>th</sup>, BRG Hunting Test August 9-11<sup>th</sup>, Fall Field Trial September 13-15<sup>th</sup>, and various Clean Up days throughout the year. Volunteer opportunities include: helping to prepare or deliver lunches to the workers, helping to get equipment out to the fields on the mornings of the events, stakes chairs, marshalling, taking and hanging birds from line, throwing birds, gunning for live birds, taking dead birds back to the shed, planting blinds, mowing, thistle and poison ivy patrol, weed whipping, gopher control, road maintenance and grounds up-keep. **Members may pay the \$30 annual membership fee without working for the club but they will not have access to the grounds for training.**

**Non-participating Membership is \$30 plus \$160 as a financial contribution allowing HCARC to hire help for Field Trials, Hunting Test and grounds upkeep.** The increase in cost reflects the cost of \$80 minimally per day to hire a worker to work the events in place of the club member. The club relies on the profits of these events to pay for improvements on the grounds. Members will be **assessed** the balance due for hours not worked when the 2019 membership forms are sent out and must be paid to renew membership for 2019.
